Officials will be assigned to games for the Deep South Classic, a recruiting tournament for Division I college coaches, featuring over 150 teams from around the country.

The Deep South Clinic is open to ALL officials.

Clinic Purpose:

- To give Division I college officials an opportunity to be evaluated by the SAWBO Coordinator, colleagues, ACC neutral observers, and other knowledgeable evaluators.
- To offer an opportunity for officials working non-Division I college games to be seen by college-level Women's Basketball Assignors including the SAWBO Coordinator.
- To offer an opportunity for officials of all levels to receive immediate feedback from veteran Division I Officiating Personnel.

Clinic Includes:

- Approximately three (3) officiating assignments per day
- Floor evaluations
- Bonus Learning Opportunities
